**EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT
BENIGNO SIMEON COJUANGCO AQUINO III FOR A
FINANCIAL GRANT AMOUNTING TO SEVENTY MILLION PESOS
(P 70,000,000.00) AS A COUNTERPART FUND OF THE NATIONAL
GOVERNMENT FOR THE CONSTRUCTION OF MODERN
PUBLIC MARKET WITH BAGSAKAN, BUS TERMINAL, AND FOOD
PROCESSING FACILITIES IN BANI, PANGASINAN.**

WHEREAS, the Municipality has undertaken several noteworthy development projects which aims to improve our town's economic conditions, foremost of these is the plan to construct a modern market with a bagsakan, public bus terminal and food processing facilities at the heart of our Poblacion;

WHEREAS, this project will effectively create a Central Business District for Bani and the First District of Pangasinan, as a wider area for business establishments will become available;

WHEREAS, the Municipality of Bani was able to secure a fixed term loan from the World Bank through the Land Bank of the Philippines amounting to Seventy Million Pesos (P70,000,000.00) which will be used to finance this monumental endeavor;

WHEREAS, it was determined during the cost estimates that the approved loan amount cannot defray the entire construction requirements of the modern market, which will in turn limit the project's social and economic impact;

WHEREAS, Bani has demonstrated that it has been a champion of good governance and people empowerment, and that all grants coursed through this municipality has been subjected to transparent, moral, and above-board procedures;

NOW, THEREFORE, upon motion of Mun. Coun. Ruben C. Ampler, duly seconded by all SB Members present, it was resolved as it is hereby;
