**RULE I**  
**SESSIONS**

**Regular Session**

**Sec. 1.** There should be a maximum of 4 regular sessions of the Sangguniang Bayan one of which will be jointly with the Association of Barangay Captains, all sessionable to be held every 1<sup>st</sup> and 2<sup>nd</sup> Thursdays commencing at 9:00 AM. and every 3<sup>rd</sup> and 4<sup>th</sup> Friday's commencing at 2:00 PM. at a place to be agreed upon by all members which place be within the jurisdiction limits of Bani.

**RULE XII**

**Sec. 1. Repealing Clause:** All resolution and Ordinance or part/s therefore not consistent with this amendment are hereby repealed:
