BARANGAY ARWAS, BANI, PANGASINAN.**

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan is aware that National Irrigation Administration (NIA) National Government Center, Quezon City is undertaking the construction of NIA Masidem Small Reservoir Irrigation Project (SRIP) at Barangay Arwas, this municipality;

WHEREAS, this Sanggunian, is likewise aware that there are lumber materials acquired from the improvements (trees) of NIA Masidem SRIP in Barangay Arwas;

WHEREAS, this sanggunian is also aware that the improvement (trees) have not been paid by NIA to the original owners;

WHEREAS, this body believes that these materials which appear to be of no use by NIA could still be used for construction purposes of houses and other buildings destroyed by typhoon "Emong" last May 2009;
